Waste Hauler

Arkansas state law, ACA 8-6-721, requires that all persons who engage in the business of collecting or transporting solid waste, in any form, must obtain a license from the Regional Solid Waste Management District.

This includes materials from construction and demolition projects, green waste, clean ups, remodel projects, as well as materials generated from any for hire services. A hauler must obtain license to conduct these types of solid waste transactions inside the Southeast Arkansas Regional Solid Waste Management Board, which includes the following counties: Grant, Jefferson, Arkansas, Cleveland, Lincoln, Desha, Bradley, Drew, Ashley, & Chicot.

By obtaining a license, not only does your business stay in compliance with state law and district regulations; you also stay in compliance with DEQ and their solid waste hauler reporting requirements.

Information and Instructions for Completing the Southeast SWMB Waste Hauler License Application

Arkansas state law, ACA 8-6-721, requires that all persons who engage in the business of collecting or transporting solid waste must obtain a license from the Regional Solid Waste Management District.

Section A What makes up a ‘Complete Application’?

A complete application consists of:

1. The Waste Hauler Application
2. Motor Vehicle(s) Registration Form
3. Licensing fee.

Please submit these documents, along with the appropriate licensing fee to Southeast Arkansas Solid Waste Management Board: 315 E. 8th Ave., Pine Bluff, AR 71601

Upon submission of a completed application and payment of the license fees, each solid waste hauler business will be provided a Certificate of License to collect and transport solid waste in the District.

Section B Licensing Fee Schedule

- **For the first vehicle registered, regardless of weight/size: \$100.00**
- **For each additional vehicle registered under the same hauler: \$10.00 per vehicle, for a maximum of \$250.00**

Operating any vehicle within the borders of the Southeast Arkansas Economic Development District; used for the collection or transport of solid waste without a license

authorized by the Southeast Arkansas SWMB, violates ACA 8-6-722. A violator will be cited and assessed a fine. Such violation may also be prosecuted as a misdemeanor and is punishable by imprisonment for not more than thirty (30) days, or a fine of not more than one thousand dollars (\$1,000), or both.

Section C Regulations Generally

1. Solid waste shall be collected and transported so as to prevent public health hazards, environmental hazards, safety hazards and nuisances.
2. Every hauler must display the one-year license decal on the driver's side of the hauling vehicle underneath the right-hand mirror.
3. All solid waste collected and transported must be covered to prevent littering on highways and roadways as required by A.C.A. 8-6-407. Violators transporting solid waste without a cover will be cited and fined and subject to criminal prosecution.
4. Yard waste must NOT be mixed with residential or commercial waste.
5. All drivers shall have the appropriate driver's license for each vehicle they will operate according to state law.
6. Failure to comply all state and local laws and ordinances and regulations addressing these conditions may result in a revocation of the hauler's license.
7. **The deadline to submit all 2025 License documents, including the Waste Hauler Application is: December 31, 2024.**

LICENSE.**
